# Acceptance of race regulations

I am aware that CHALLENGE HEILBRONN is underlies the race regulations of the German Triathlon Federation DTU (sport rules, league rules, doping rules, marshal rules) as well as the legal order and disciplinary code, which can be inspected at the organizers and on race day. # Acknowledgement of directives

### Responsibility for personal belongings / mandatory helmets

I understand and agree that I solemnly are responsible for my personal belongings and sports gear, especially their technical condition during the race and the therewith connected activities. I will wear a correspondent helmet throughout the bike course.

#### State of health

I herewith assure that I am physically and mentally fit as well as trained enough for the race and that my fitness has been attested by a physician.

#### Medical treatment due to a race accident

I already now declare my approval to be treated medically during the race if this would be advisable at the occurrence of injuries, in case of an accident and/or illness during the course of the race. Any usage of medical services – also in the frame of regenerative infusion therapies – is subject to costs and will be born of by the health insurance or privately.

In addition, I indemnify the organizers, hosts and volunteers from any third-party liability as far as they result during the event from my participation of the race.
